FY 2020-2021 Call for Proposals

- Research Directors raised concerns with unilateral - and significant - changes to the funding proposal templates and process shared by Negotiation Support Directorate (NSD) in December 2019
- To address the concerns, we reconvened the CRU-NSD Working Group
- Over the course of 2020, it was made clear to the CRU members of the working group that only \$10M of the \$12M funding envelope was allocated in FY 2020-2021
- \$2M held back...

"...to support other activities supporting the advancement of the Specific Claims Research program such as: policy development, consultations, and joint research studies."



Purpose of the Working Group:

- Troubleshoot funding issues as they arise
- ➤ Co-develop solutions that are responsive to First Nation and Claims Research Unit (CRU) needs.



Under subscribed?

It means there was surplus funding in Canada's specific claims research budget each year.

Guidelines? But we're talking about shortfalls!

- NSD noted that they needed to increase interest (and use of) specific claims research funding because the program was "under subscribed."
- To make the funding opportunity public, they needed to develop and publish "Funding guidelines" on website to assist applicants in submitting their proposals.



Updating Funding Guidelines

August & October 2020

- ➤ CRU members of working group meet. CRU members see NSD/SCB's unilaterally drafted funding guidelines for first time (August).
- > We continue to address significant concerns with guidelines and lack of movement by SCB/NSD on contents (October).

December 2020


NSD noted that new funding guidelines needed to be finalized and published publicly by April 1, 2021.


March 2021

- > SCB circulated updated draft guidelines to be published less than two weeks later.
- Research Directors email Stefan Matiation (SCB DG) with concerns about April 1 deadline.
- > SCB delays posting of guidelines until June 2021.



What have we have done?

July 2020: NCRD releases open letter to then-Minister Miller calling for immediate response to \$18.5M funding shortfall this fiscal year

- AFN & UBCIC passed resolutions, calling on Canada to properly fund First Nations who applied to research specific claims
- Endorsement letters pour in from First Nations and Indigenous Organizations nationwide
