

Formal Requests for Indigenous Related Records 2024-25

- Formal ATIP requests carried over from previous year: 150
- Formal ATIP requests received: 600
- Formal ATIP requests closed: 424 (160,505 pages)
- Formal outstanding ATIP requests: 325
- Formal overdue ATIP requests: 84

Material Under Assessment or Recently Opened via Proactive Access (Block Review)

- PROJECT UNDERWAY: INAC Records on Record keeping Indigenous Services Canada gets lots of questions from their clients on INAC historical record keeping practices.
 - It is in its final stages and will represent 465 files (approx. 116,250 pages) when complete.
 - It focuses on the INAC Modified Duplex Numeric Classification System file number subject code 1-6, which covers Methods and Procedures under the Organization and Administration subject block (i.e. record keeping files).
 - Project covers files from 1948 to 1986.
- Treaty Annuity Paylists and Interest Distribution Annuity Paylists from 1882 to 1933. <u>MIKAN</u> <u>133552</u> / Use <u>thematic code "BR 406"</u>)
 - Opened over 1,500 Treaty Annuity and Interest Distribution Annuity Paylists from 1882 to 1933 (approx. 37,500 pages opened)
 - Paper paylists and the microfilm copies were opened, with the Access and Services Branch moving the opened microfilm reels to the self-service area at 395 and pursuing digitization of those reels, enabling greater access to those paylists.

Material Under Assessment or Recently Opened via Proactive Access (Block Review) – Cont'd

- Day School records Day school building files, aerial photographs (Use <u>thematic</u> <u>code "BR 426"</u>)
 - Only opened 21,567 pages (out of 800,000) because of the unpredictability and the amount of sensitive personal information in those files.
- Consolidated Fund Ledgers dating from 1899 to 1932. (<u>MIKAN 133555</u>) The Ledgers opened are volumes 11655--11656; 11662—11687 (See Finding Aid 10-47)
 - These ledgers record Canadian Government expenditures on goods and services that fulfill Treaty obligations.
 - This project opened approx. 28,000 pages, allowing the requestor to gain access to those records within a week of the request being made.

Challenges

- Newer team members are still in training and productivity will increase over time
- Reduced government spending means the team may not grow further
- Increased number of requests (more than doubled from last fiscal year)
- Increased number of pages per request in average
- Litigations without added funding is putting pressure on our regular operations output (ex: "Indian Boarding Homes (Percival)" and "First Nations Child and Family Services (FNCFS) and Jordans's Principle (Moushoom/Trout – AFN)" and the "Federal Indian Hospitals" settlement approval hearing will be on June 10th 2025
- Difficulty processing 8(2)(k) requests

Improvements/Opportunities

- Application fee of 5\$ remains *waived* for ATI request for Indigenous requesters or their representatives.
- New process for formal ATI requests without references they are put on hold and sent to our Research Support team to identify the proper archival references
- Change in the number of analysts working on Indigenous records:

2021-2022	2022-2023	2023-2024	2024-2025	2025-2026
0	3.25	5.75	7.66	8.17

- Since June 2024 previously <u>completed formal ATI requests</u> on archival records have been published on LAC's website – going back approximately 10 years
 - As of March 31 2025:
 - 12,261 downloads/10 046 views
 - RG10: 1 057 downloads/1 501 views
 - RG22: 15 downloads/68 views
 - RG85: 77 downloads/97 views

Conclusions and Next Steps

- Reduce and ultimately eliminate backlog of overdue formal requests (84)
- If you don't require personal information or are unsure, submit a formal ATI request and our team can revisit the ATI request for personal information disclosure under 8(2)(k) as a second step.
- Multiple smaller requests vs one large request can be processed more quickly
- Possibilities for tackling the backlog to be examined
- LAC will reach out to requesters, researchers and Indigenous communities when necessary
